You possess following skills and experience

- Should be a member of a recognized body of a professional accountants or possesses a post-graduate degree in finance, accountancy, business management, commerce, economics, capital market and financial services or other related discipline from a university recognized by the Higher Education Commission of Pakistan, or equivalent
- Should have a minimum experience of seven years in a senior level managerial position preferably as chief operating officer/ Head of Operations at the securities exchange or have served at a senior management position preferably as chief operating officer/ Head of Operations for a period of ten years in any other company of substantial size in the regulated financial services sector.
- Should not have been in service as any senior management position with any TRE certificate holder or an associated company of such TRE certificate holder during the last three years.
- Age of candidate should not above sixty years of age.
- Should have strong communication and interpersonal skills. The role requires frequent presentations and interactions with PSX Board of Directors and senior management.
