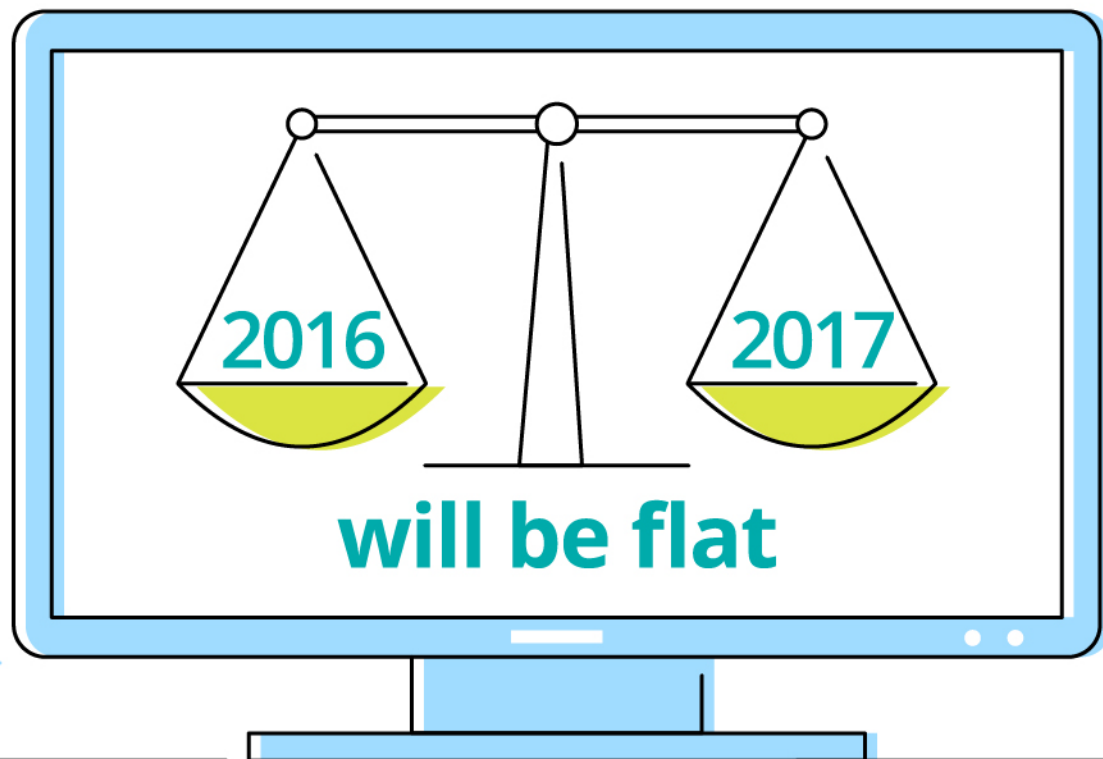


TV advertising in the US: flat is the new up
