

The RO e-Invoice is a digital system stemming from an initiative to amplify transparency and efficiency in B2B and B2G transactions.





### **Key features of RO e-Invoice**

Digitization & Accessibility

Paper invoices shift from the present to archives, replaced by easily manageable digital versions.

Phased Implementation

Initially used for B2G transactions and then extended to B2B transactions with goods with high fiscal risk, from 2024 it will be applied to all B2B and B2G transactions.

Fraud Reduction

It greatly aids in curtailing tax evasion and VAT fraud both nationally and across  $\mbox{\it Europe}.$ 

European Interconnection

Will link with similar systems in other EU member states.

Enhanced Security

Removes vulnerabilities associated with paper invoicing.






