

The digitalization marathon:

**SAF-T implementation in Romania** 





Time has come for Romania to make an important step towards digitalisation in the tax reporting field and implement SAF-T.

The plan is for SAF-T reporting to become mandatory for Romanian large taxpayers **starting January 2022**, **having the submission deadline in February 2022**. The other taxpayers will be on-boarded at a later stage.

Beginning August 2021, the SAF-T platform should be ready to be used/tested by interested taxpayers, not only large ones.

Briefly, the Romanian SAF-T schema follows the OECD 2.0. version where detailed information regarding clients, suppliers, accounting bookings, tax treatment of transactions, stock movement and information regarding payments needs to be reported. Part of the information will be submitted regularly, while other only once a year or on demand.

Having a mix of IT, tax and accounting subject matters will increase the chances of a smooth implementation process. Reviewing the business routes, the data gathering processes and framing the information into a standard file for sure will need resources and will raise challenges.

On top of that, the tight deadline will make this implementation a marathon, one that we are ready to run for together with you.

Nevertheless, a successful implementation recipe will need to have the below four main ingredients:



### **Review of data**

Perform a quantitative and qualitative analysis of the data available in various systems to determine if additions are required or if tax risks need mitigation.



### Data mapping

Define key general aspects to ensure compliance with SAF-T reporting (mapping of charts of accounts, tax codes, tax treatments)



## Implementation of SAF-T reporting solution

Identify the best technical solution (standardized or customized) and work on the implementation of the tool or outsource the reporting.

## Deployment and go-live

After data validation is completed, train the teams, start using the SAF-T reporting solution and submit the SAF-T report
