## The deadline until when the fire safety authorization must be obtained for the constructions and establishments that were operated without such authorization was extended until 30 September 2017

The draft of Law for the approval of the Government Ordinance no. 17/2006 for the extension of the term provided by art. 30 par. (41) of Law no. 307/2006 on fire protection was adopted by the Chamber of Deputies on 23rd of May 2017 and sent to the President of Romania to be promulgated on 7th of June 2017.

On 26th of June 2017, the President of Romania promulgated the draft of law, thus the natural or legal persons financing and performing new investments or interventions upon the existing constructions or, as the case may be, the beneficiaries shall have the obligation to obtain the fire safety authorization for the constructions and establishments that were put into operation without such authorization until 30th of September 2017, the latest. Previously, the term was extended several times, the last extension being provided by the Government Emergency Ordinance no. 52/2015, through which the deadline was postponed until 30th of June 2017.

The law will be published in the Official Gazette and shall enter into force in 3 days after the publication date.
