### **Amendments to the procedure for state registration of legal entities and individual entrepreneurs**

Federal Law No. 67-FZ of 30 March 2015 has amended the procedure for the state registration of legal entities and individual entrepreneurs. The Federal Law comes into force from the day of its official publication with the exception of separate regulations, for which different dates of coming into force are stipulated.

### **Cooperation of tax authorities and companies providing audit services**

It is reported that the [Draft](#) Federal Law “On the introduction of amendments to articles 82 and 93/1 of part one of the RF Tax Code,” in accordance with which organisations providing audit services must pass information received from clients to the tax authorities about the calculation and payment of taxes, has been uploaded to the single portal for draft acts.
