### **Procedure for preparing single amending VAT invoices for goods with identical names and prices**

In this letter, it is reported that organisations may indicate in box 3, line A of a single amending VAT invoice the total amount of delivered/dispatched goods/completed works/rendered services and transferred property rights, with identical names/descriptions and prices/tariffs in VAT invoices for which a single amending VAT invoice has been issued.
