### **VAT refund to non-resident individuals in relation to goods purchased on Russian territory for personal use**

It is reported that the Prime Minister of the Russian Federation has [requested](#) that RF Ministry of Finance and the RF Ministry of Economic Development develop a draft law in accordance with which non-resident individuals would have the right to receive VAT refund on goods purchased on Russian territory for personal use upon transporting said goods out of the customs territory of Russia.
