## Deloitte-ICAEW Scholarship 2024

### Application guide and FAQs

**1. Who is eligible for the Scholarship?**

The Scholarship is open to all diploma undergraduates studying Accountancy / Accounting & Finance who have completed their first or second academic year and are starting their second or third year in April 2024.

**2. What is the value of the Scholarship?**

The successful candidate will be provided with financial support valued at SGD 5,000/- per academic year (Year two and Year three only). The student will also be offered an internship with the Audit & Assurance service line at Deloitte Singapore and their professional qualification with ICAEW will be sponsored.

**3. What do you look for when considering the Scholarship application?**

We take a holistic view of the candidate's academic excellence, overall development, track record in co-curricular activities, as well as the student's interest in pursuing a career in Audit & Assurance. The GPA criteria for the eligibility to the Scholarship is 3.2 and above.

**4. Will I be required to maintain a certain GPA score for the duration of my course?**

We expect our scholars to do well consistently. If the scholar fails to maintain academic standards, we may discontinue the Scholarship grant, but this will not be retroactive.

**5. Will I be required to do a compulsory internship with Deloitte?**

We strongly encourage our scholars to complete an internship with Deloitte Singapore.

**6. Will there be an obligatory service after I graduate?**

All scholars are required to complete two years of service with Deloitte Singapore upon graduation or after the completion of their National Service.

**7. What is the selection timeline?**

Shortlisted applicants will go through a screening process. The timeline is as follows:
