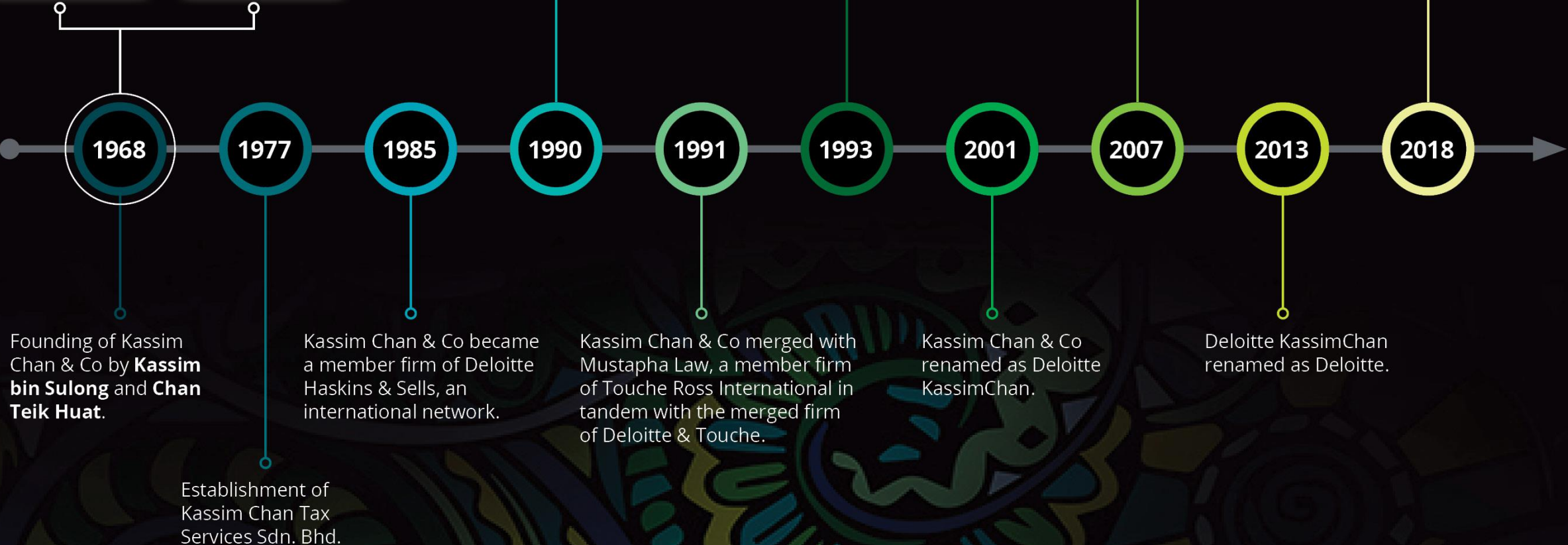


Worldwide merger of Deloitte Haskins & Sells and Touche Ross International forming Deloitte & Touche.

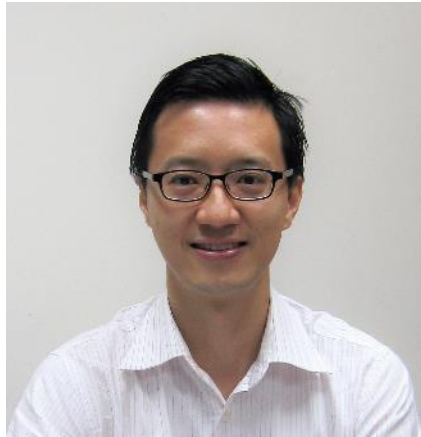
