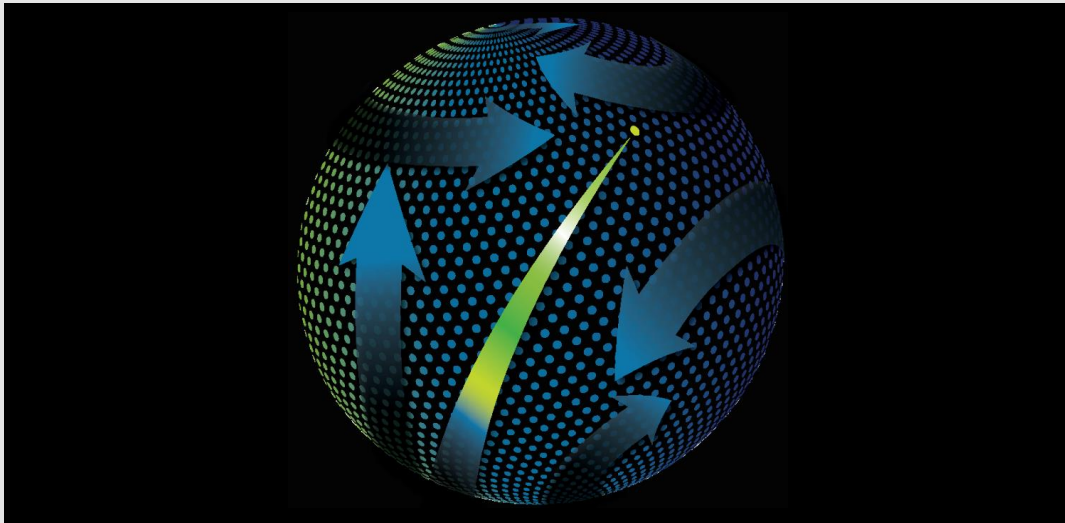

Cambodia

Quarantine for unvaccinated visitors reduced to seven days

Cambodia has reduced the required quarantine period from two weeks to seven days for arriving travellers who are not fully vaccinated against COVID-19. Those arriving by air must take a rapid antigen test on the last day of their quarantine, while those arriving by land are required to take a rapid antigen test on arrival, as well as on the last day of quarantine.

Myanmar added to list of places for recognised vaccination records

The Government has announced that from 27 April 2022, it will accept COVID-19 jab records from Myanmar as **recognised vaccination records** for people arriving from overseas places. According to current measures, travellers who have stayed in any overseas place may only board a flight for Hong Kong if they are fully vaccinated and hold recognised vaccination records.

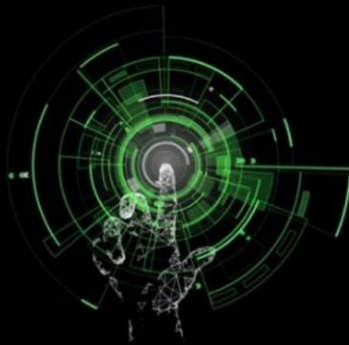
