0900	US Tax Reform and the impact on financial services Tax reform legislation in the US has been passed by both the House of Representatives and the Senate and signed by President Trump. The new law reduces the federal corporate tax rate to 21 percent effective in 2018 and moves the US toward a limited territorial-type tax regime. This session will outline key provisions and address the impact of US tax reform on both US inbound and outbound Financial Institutions. Sector-specific issues will be identified and discussed. 1045	<p>Option A. BEPS and transfer pricing update</p> <p>This session will cover a range of BEPS and transfer pricing developments in the Asia Pacific region. BEPS to be discussed will include digital related developments (including the impact of Action 1 on Fintech) and the practical impact of Actions 8-10 for Banks and Insurance groups. This session will also cover the domestic responses to BEPS as well as the expected risks (e.g., the use of CBCR information, and for instance, the impact on APA negotiations). The transfer pricing part of the session will focus on audits, audit risk and defence strategies, including current APA trends. 	<p>Option B. Investment Management</p> <p>The investment management breakout will focus on a range of topics relevant to traditional and alternative asset managers in the region.
