Greetings from your tax team at Deloitte Singapore. We are pleased to update you on the following:

### **Singapore: Mandatory use of CorpPass begins**

Effective tomorrow, 1 September 2018, employers will have to use CorpPass to log in into Employment Pass Online (EPOL) or in facilitating other business transactions with Singapore Government agencies.

Companies can use a CorpPass account to access digital services of different agencies such as the Ministry of Manpower (MOM), the Central Provident Fund (CPF) and the Inland Revenue Authority of Singapore (IRAS).

### **Deloitte Singapore's view**

Deloitte Singapore recommends that employers complete the registration for a CorpPass account on the [CorpPass website](#) as soon as possible to avoid disruptions in facilitating transactions with the MOM or other government agencies.
