

COVID-19

Hong Kong

Government tightens boarding requirements for persons arriving from Colombia and South Korea

Government of the Hong Kong special administrative region (SAR) | 11 June 2021

With effect from 18 June 2021, the Government will specify Colombia and South Korea as group B specified places. Persons arriving in Hong Kong who have stayed in group B specified places in the last 14 days will be required to present proof of a negative result for a COVID-19 nucleic acid test conducted within 72 hours before the scheduled time of departure of the aircraft, as well as confirmation of a room reservation in a designated quarantine hotel in Hong Kong.

Persons arriving in Hong Kong who have stayed in group B specified places but are yet to be fully vaccinated with COVID-19 vaccines will be subject to a 21-day compulsory quarantine at designated quarantine hotels, with four tests to be conducted during the period.

Persons who have been fully vaccinated will be subject to a 14-day compulsory quarantine at designated quarantine hotels, with three tests to be conducted during the period, followed by a seven-day self-monitoring period, as well as compulsory testing on the 16th and 19th day of arrival in Hong Kong. Fully vaccinated persons refer to those who have received the suggested dosage in accordance with relevant guidelines at least 14 days prior to their arrival in Hong Kong. Singapore

Singapore eases border measures for travellers from Israel, tightens measures for arrivals from Fiji

Travellers who have remained in Israel for 21 days before arriving in Singapore will be allowed to spend the last seven days of their 21-day stay-home notice at a place of residence or self-sourced accommodation. This measure will take effect for travellers from Israel who arrive in Singapore from 11.59 p.m. on 16 June 2021. Currently, travellers from Israel must spend the entirety of their 21-day stay-home notice at a

dedicated facility.

On the other hand, all travellers who have spent time in Fiji in the 21 days before arriving in Singapore will be required to serve a 21-day stay-home notice at a dedicated facility. Prior to this, travellers from Fiji were allowed to spend the last seven days of their stay-home notice at a place of residence or self-sourced accommodation. Travellers who have not completed their 14-day stay-home notice at dedicated stay-home notice facilities by 11.59 p.m. on 16 June 2021 will be required to serve the additional seven days at their current dedicated stay-home notice facility. These travellers will be contacted regarding the additional costs to be paid.


