

COVID-19

The COVID-19 pandemic is a rapidly evolving situation, and authorities across the globe frequently update their travel advisories and immigration policies in response to the outbreak situation on the ground. Bangladesh

Mandatory institutional quarantine for passengers from the United Kingdom (UK)

Civil Aviation Authority of Bangladesh | 23 January 2021

In addition to the requirement to present a negative COVID-19 polymerase chain reaction (PCR) test certificate, passengers arriving in Bangladesh from the UK (directly or through intermediate points) will be sent to government-selected hotels for a mandatory institutional quarantine period of seven days. All expenses of the hotel stay will be borne by the passenger. Those who are unable to bear the expenses will be institutionally quarantined at selected centres to be arranged by the Government.

After the 7-day period, samples will be collected for another COVID-19 PCR test. If the test result is negative, the passenger will undergo home quarantine for the remainder of the 14-day quarantine period. If the test result is positive, the passenger will be sent to a government-selected hospital for isolation. All expenses at the hospital will be borne by the passenger.

Temporary suspension of entry for foreign nationals from Canada

Consulate-General of the People's Republic of China | 30 January 2021

All foreign nationals holding valid Chinese residence permits for work, personal matters, and reunion will not be allowed to enter China from Canada. Entry with diplomatic, service, courtesy or C visas will not be affected. Foreign nationals in Canada coming to China for essential economic, trade, scientific, or technological activities, or for emergency humanitarian needs, may contact the [Chinese Visa Application Service Centre in Canada](#) , and submit their visa applications after receiving confirmation from the Centre.

Scheduled international commercial passenger flights suspended until 28 February 2021

Directorate General of Civil Aviation | 28 January 2021

Scheduled international commercial passenger flights to/from India will remain suspended until 11.59 p.m. (IST) on 28 February 2021. This restriction shall not apply to international all-cargo operations and flights specifically approved by the Directorate General of Civil Aviation.

Announcement on extension of the precautionary restriction measures relating to control of the COVID-19 pandemic

The Global New Light of Myanmar | 31 January 2021

In order to reduce the risks of importation and spread of COVID-19, the Government of the Republic of the Union of Myanmar has decided to extend the following existing entry restriction measures until 28 February 2021:

- Precautionary measures for all travellers visiting Myanmar ([announcement](#) dated 15 March 2020)
- Additional precautionary measures for travellers visiting Myanmar and temporary suspension of issuance of visa on Arrival and e-visa ([announcement](#) dated 20 March 2020)
- Additional precautionary for travellers from all countries visiting Myanmar ([announcement](#) dated 24 March 2020)

- Temporary suspension of all types of visas (including social visit visas) and visa exemption services ([announcement](#) dated 28 March 2020)
