Malaysia

Kuala Lumpur and Johor Bahru among areas placed under Movement Control Order (MCO) under retightened restrictions

Kuala Lumpur and Johor Bahru are among the areas placed under a MCO from 7 May to 20 May 2021, as the Government retightened COVID-19 restrictions. Additionally, 14 sub-districts in Besut, Terengganu, as well as the sub-district of Taiping in Perak would also be placed under a MCO. These latest restrictions come after six districts in Selangor were placed under an MCO effective 6 May until 17 May 2021.

Vietnam intensifies border checks

Vietnam has ordered a strict border control as it traces the recent flare up in coronavirus cases to overseas travellers. Authorities will also go “district by district, house by house”, and visit companies hosting overseas workers to contain any spread.

Vietnam extends quarantine period (Translated from Vietnamese)

Ministry of Health | 5 May 2021

With effect from 4 May 2021, the quarantine period for travellers will be extended to include centralised isolation for at least 14 days, followed by home quarantine for another 14 days. COVID-19 testing will be conducted on the 7th day from the end of the central isolation. If the test result is negative, the traveller can continue to complete the full 14 days of the prescribed home quarantine. If the test result is positive, the traveller will be required to isolate at prescribed medical facilities.

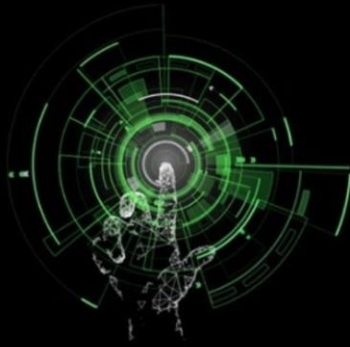
