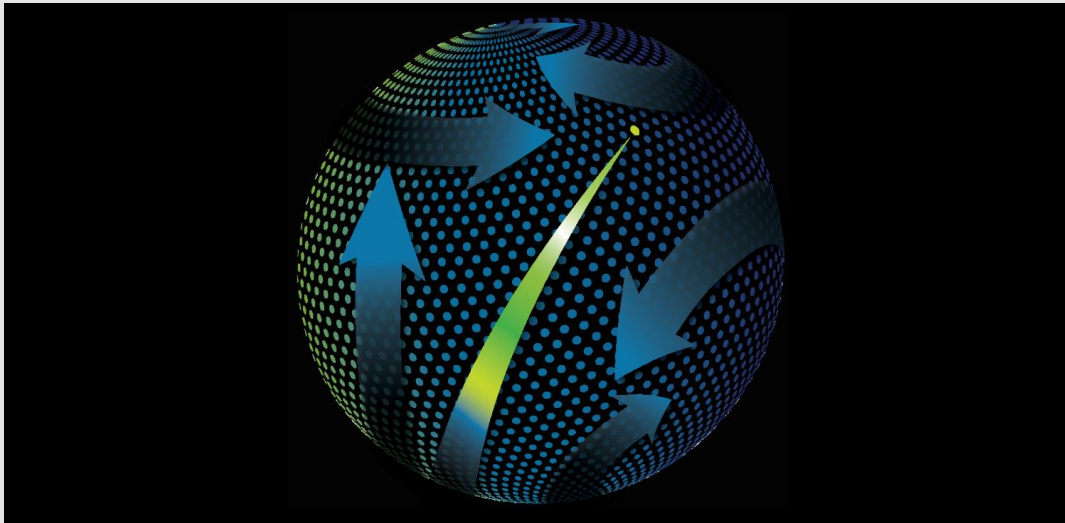

Japan

Tokyo to be placed under COVID-19 state of emergency until 22 August 2021

The Government has announced that Tokyo will be placed under a COVID-19 state of emergency from 12 July 2021 to 22 August 2021 to curb a recent surge in infections. In addition, the state of emergency already in place in Okinawa, and the quasi-state of emergency covering Chiba, Saitama, Kanagawa, and Osaka have also been extended to 22 August 2021.

The quasi-state of emergency currently in place on five other prefectures—Hokkaido, Aichi, Kyoto, Hyogo, and Fukuoka—will expire on 11 July 2021 as scheduled. The measure carries fewer restrictions on business activity, and targets high-risk areas rather than entire prefectures.

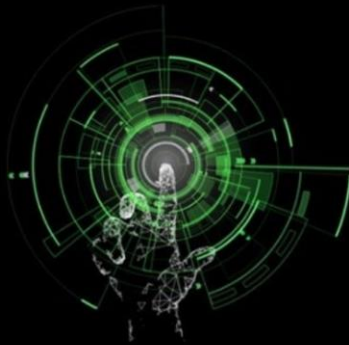
