

## Government rationalises testing arrangement for persons arriving from Mainland and Macao

The Government of the Hong Kong Special Administrative Region | 1 September 2022

The Government has announced the rationalisation of the COVID-19 nucleic acid testing arrangement for persons arriving from the Mainland and Macao from 3 September 2022.

Under the new arrangement, persons arriving in Hong Kong from the Mainland or Macao via the airport will no longer be required to undergo "test-and-hold" arrangement. However, they must undergo compulsory nucleic acid testing on Day 2 of their arrival.

This arrangement is applicable to persons required to undergo compulsory quarantine at home, as well as those arriving under the Return2hk or Come2hk schemes.

From 7 September 2022, nationals of <u>visa-exempted countries/regions</u> will be able to apply for multiple-entry short-term stay visas for the purposes of business affairs and for the spouse or child of a Japanese national.
