

Public consultation on proposed Multinational Enterprise (Minimum Tax) Regulations—GloBE Safe Harbours and Transition Rules

The Inland Revenue Authority of Singapore (IRAS) launched a <u>public</u> <u>consultation on the proposed subsidiary legislation under the Global Anti-Base</u> <u>Erosion (GloBE) rules</u> consisting of the following from 4 October 2024 to 18 October 2024:

- 1. <u>Multinational Enterprise (Minimum Tax) (GloBE Safe Harbours)</u> <u>Regulations</u>; and
- 2. <u>Multinational Enterprise (Minimum Tax) (Transition Rules) Regulations</u>
