On August 24, 2018, the Salvadoran Tax Office (DGII) informed to the taxpayers that as of September 1, 2018 they must file and generate online, the following:

a) Return of Specific and Ad Valorem Taxes (F-06)

both cases, taxpayers will have the option to pay through electronic banking or by printing the Payment Order with NPE, in order to pay (if applicable) at authorized financial institutions or collection offices of the General Treasury Office.

Due to the above, it is necessary for Taxpayers obligated to file the Return of Specific and Ad Valorem Taxes (F-06) and those who make payments for the importation or entry of services to non-residents to take into account the press releases issued by the DGII regarding the online methods of complying with both obligations, which will be available as of September 1, 2018, in order to avoid any issues or non-compliance with the legal terms.
