

### **Eligibility Criteria**

### To be eligible to apply for this program, companies must meet the following criteria:

- In operation for at least 5 years
- Annual revenue or enterprise value should be at least USD 50 million (in the most recent financial year)
- HQ or major decision-making centre in Thailand
- Fully compliant with the prevailing legal, tax and ethical frameworks within the operating countries
- Public companies where the majority stake (> 50%) is privately-held by residents or entities within Thailand
