Transatlantic ties

The United States and United Kingdom have strong cultural, political and economic ties. Their trading and investment relationship is one of the largest in the world. Bilateral trade reached \$225 billion in 2016 and the two nations are each other's largest foreign direct investors. In terms of imports and exports the US is the UK's second largest trading partner.

More than 1.1 million Americans work for British companies in the US, and nearly 1.4 million Britons are directly employed by US affiliates.

The level of M&A deal flow between the UK and US renders it the biggest bilateral deal corridor in the world by volume. Our most recent Deloitte US/UK M&A Deal Monitor shows UK deal making into the US rising by almost 10% in H1 2017.
