


### Typical Making Tax Digital Journey:




### Digitisation of tax

MTDfV is set against the backdrop of a rapidly changing global tax environment, one where real time reporting requirements are becoming ever more commonplace, and the digitisation of tax is high on many tax authorities' agenda. As a result, many businesses are treating MTDfV as a catalyst for change to transform their UK and international Indirect Tax processes.

### What do I need to do about digital links from April 2021?

From April 2021, Digital Links must exist between all programs that are used in your VAT compliance process. You cannot copy paste data between sources of data and you will need to automate the creation of the VAT return as far as possible.
