



## Luxembourg modifies list of Participating Jurisdictions for CRS purposes

### The road continues

On July 6, 2016 the Government of Luxembourg published a [press release](#) (in French) announcing the adoption of a draft regulation amending the Grand-Ducal Regulation of March 15, 2016 which implements article 2, paragraph 4 of the Law of December 18, 2015 regulating the Common Reporting Standard (CRS) in Luxembourg.

The new draft regulation will amend the list of Participating Jurisdictions in order to include those that have recently signed the CRS Multilateral Competent Authority Agreement such as Israel, St. Kitts and Nevis and Russia. Additionally, the United States will be removed from this list of Participating Jurisdictions as it does not comply with the requirements to be considered a Participating Jurisdiction within the context of Luxembourg's CRS regulations. This approach is in line with the position adopted by other European Union Member States and by the Global Forum.
