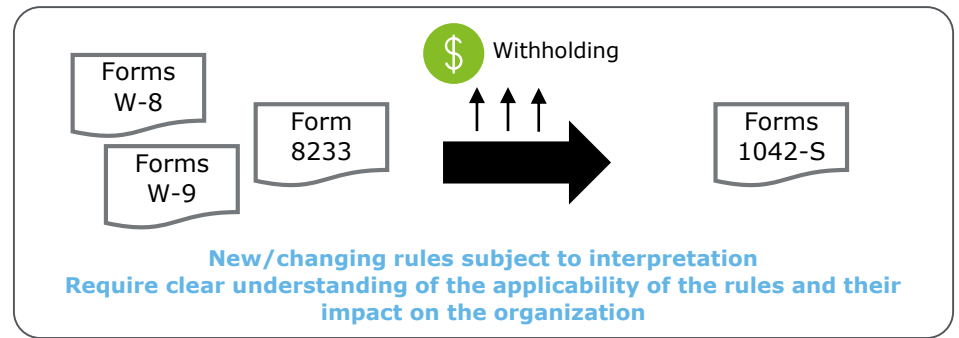
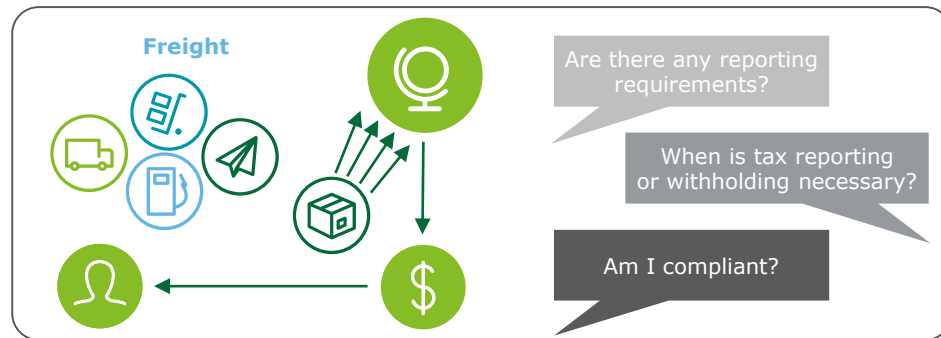


Tax information reporting requirements

Freight costs



Issues and concerns

- Certain freight payments made to foreign providers are treated as services and may be subject to withholding and reporting
 - Generally air and ship freight payments are exempt from withholding provided the excise tax has been paid
- Treaty relief may apply to freight payments and it is therefore important that valid Forms W-8 are collected when required
- Freight payments are sourced based on the origination and the destination of the shipment and therefore accurate records should be maintained
- Without adequate controls to collect documentation and to classify the type and source of the payment and withhold, if required, a company may be liable for any withholding tax.
