Integration with Grants.gov

An automated interface with Grants.gov allows you to receive standard federal application forms and attachments, as well as to extract data from the standard forms into a repository for further analysis. This eliminates the need for manual tracking of application data and helps increase staff efficiency while promoting a paperless environment. Your staff can easily report on application data and the latest status of each grant application.

Financial system integration

SAP Grantor provides a central platform for managing the business processes related to planning, selecting, and managing your grant programs. It gives key stakeholders access to the latest financial and grant data. The integrated OpenText document management system provides a single shared repository for storing and managing grant-related documentation. The repository integrates with SAP Grantor to make digital assets available within enterprise business processes and helps increase financial oversight and proactive monitoring.

Business process automation and activity tracking

The system automates key business processes, enabling faster approvals through electronic routing. It includes preconfigured workflows for RFA approvals and awards, promoting consistent business practices and efficiency. Additionally, activity tracking functionality allows for tracking of due dates for key grant activities, and sends notifications to help keep grant activities on schedule and to promote accountability.

Panel review scorecard

A panel review scorecard improves efficiency by collecting reviewer scorecards and simplifying communication and collaboration. Automatic compilation of reviewer scores through reporting features saves time and can accelerate the pre-award process.

Access control, security, audit, and records management

Advanced security features can help you control user access to the searchable repository down to the document level and provide documented proof of access controls and versioning. Permission to access content can be granted based on user roles, making it

easier to systematically control the maintenance and disposition of grant records. An audit trail of user access to electronic documents also simplifies compliance.

Maintaining electronic files in the OpenText repository makes it possible to manage the documents according to records management disciplines. Sensitive data can even be encrypted using built-in encryption capabilities, and documents can be archived, preserved, or destroyed based on agency needs.

These features can not only simplify compliance and reduce the risk of data breach or data loss, but also enable greater efficiency in managing documents and greater transparency throughout the award life cycle.
