Eligibility

In accordance with the Official Rules, the following are some examples of student situations and the eligibility decisions appropriate for each.

Coursework/Full-Time Status

Students should be classified in the same manner in which the university's business school classifies them for current enrollment status (regardless of the number of tax classes taken).

| Facts/Situation | Eligibility Decision |
|--|---|
| A student currently enrolled in a graduate program. | Not eligible to compete |
| A student in his/her fifth year of a 5-year program | Not eligible to compete |
| A student in his/her fourth year of a 5-year program | Eligible to compete as a senior |
| First semester sophomore currently enrolled in first accounting course | Eligible to compete as a sophomore |
| Students with AP credits | Eligible for participation/level to be based upon business school classification. |

Listing for Prior Work Experience Facts/Situation Number of months FTE* Eligibility Decision

| Facts/Situation | Number of Months FTE* | Eligibility Decision |
|--|-----------------------|--|
| Worked as a store clerk | N/A | Eligible – experience not relevant |
| Worked for financial tax preparer for five years | 60 months | Not eligible – experience relevant and exceeds 12 month limit |
| Worked as a bookkeeper (general ledger entries, payroll, A/R, A/P, financial statement preparation) part time (20 hrs/week) for 20 months | 10 months | Eligible – experience considered relevant but less than 12 months |
| Full-time bank teller for four years | 48 months | Eligible – experience not relevant |
| Worked for local CPA firm part-time (20 hrs/week) for 24 months as a staff auditor and full-time for eight months (two busy seasons) as a tax preparer | 20 months | Not eligible – both experiences considered relevant and exceeds 12 month limit |
| Worked as an intern for a local or Big 4 CPA firm full-time (40 hrs/week) for 4 months (1 semester) as a staff auditor or tax assistant | 4 months | Eligible – experience is relevant but not counted towards 12-month FTE limit (i.e. student not penalized for having relevant internship) |

*FTE = Full-Time Experience
