2013 Carl H. Lindner Award for Entrepreneurial and Civic Spirit

The ninth annual Carl H. Lindner Award for Entrepreneurial and Civic Spirit is being presented to a business leader who personifies the leadership, business success, and civic involvement which was characterized by Carl Lindner in our community. As we continue to celebrate the life and accomplishments of Mr. Lindner, we are very pleased to present the 2013 recipient of the Carl H. Lindner Award for Entrepreneurial and Civic Spirit to Mr. Gary Heiman.

Gary Heiman is the President and Chief Executive Officer of Standard Textile Co., Inc. [STC], the world's largest, vertically integrated manufacturer and distributor of institutional textiles and apparel.

Prior to returning to his hometown of Cincinnati in 1986, Mr. Heiman lived in Israel for 14 years. A holder of dual citizenship, he served in an elite, search-and-rescue unit of the Israel Defense Forces before establishing Standard Textile's first manufacturing facility in Arad in 1975. In 1997, STC became the first American company to build a manufacturing facility in Irbid, Jordan, part of a joint venture with Century Investment Group in Amman. The plant supported the U.S. government's efforts to bring economic benefits of the peace treaty between Jordan and Israel to the local people where unemployment stood at 40%. Today, the company has three manufacturing facilities in Jordan employing more than 1,300 workers. STC is also the only U.S.-based textile company with one of the largest vertically integrated manufacturing facilities in China.

In 2001, Mr. Heiman was awarded the "Industrialist of the Year" Prize by the President of the State of Israel. In 2008, he received the "Pioneer of Negev" award by the President of the State of Israel which recognizes him as one of the 12 major contributors to the development of the Negev desert.

Mr. Heiman received his undergraduate degree from Washington University in St. Louis in 1972. He completed postgraduate work at the Georgia Institute of Technology, studying industrial engineering. He also studied mechanical engineering at the Saurer Institute in Arbon, Switzerland.

He is a member of the Board of Trustees of the University of Cincinnati where he also serves as Chairman of the Finance and Administration Committee. Additionally, Mr. Heiman is Chairman of the Board of Trustees of the Jewish Foundation of Cincinnati, former Chairman of the Jewish Community Center, a member of the Cincinnati Business Committee, and former Chairman of the Board of The Jewish Hospital of Cincinnati.

Mr. Heiman and his wife, Kim, have three grown children.
