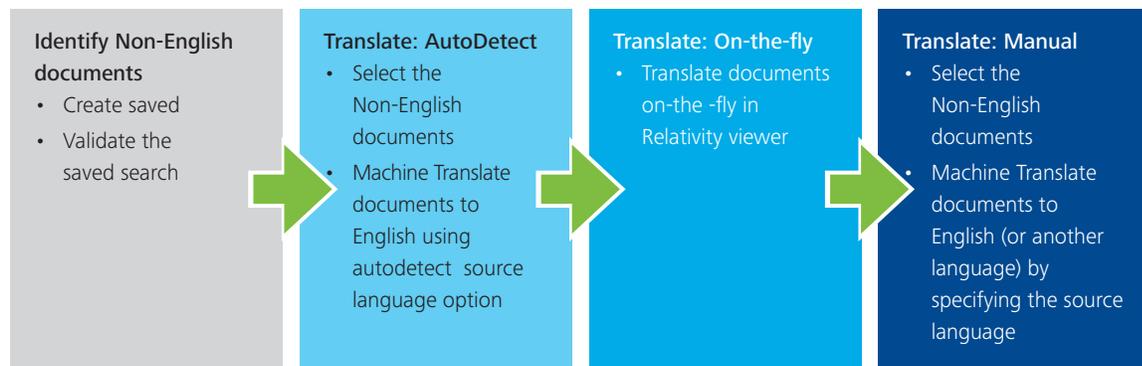

Unlike other translation mechanisms that may exist in the cloud or on third-party infrastructure, Deloitte Assisted Translation is accessed through the Relativity interface on Deloitte servers. With Assisted Translation, there are multiple ways to both identify and translate documents.



### Intelligent Detection

Language types can be identified in a number of ways:

1. The processing platform can be setup to identify the language type during processing.
2. The hosting platform, such as Relativity, can use analytics to determine language type if not already determined by processing application or in addition to validation.
3. Through human review and determination of the language type.
4. Through auto-detection, the software can quickly and efficiently detect the language type on-the-fly.
