- How will the company’s growth be funded?
- Does hidden value exist that insiders have not identified?

- Analysis of working capital and identification of improvement opportunities
- Focus on sources of low performance for improvement strategy
- Identification and prioritization of improvement focus areas

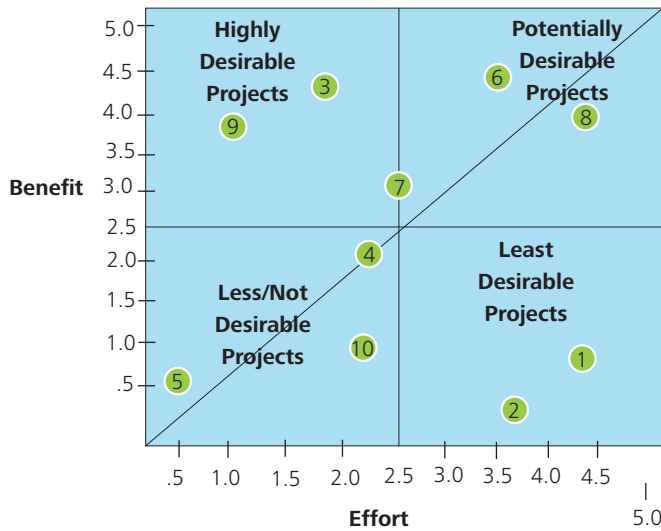
