


## Biopharma digital transformation


**Certain digital technologies such as the Cloud, AI, Data Lakes & wearables have been adopted in day-to-day operations**



Digital innovation is a burning priority; momentum will likely continue post pandemic





Say digitalization of operations will continue even after the pandemic ends
