World Tax Advisor: China's SAT issues guidance on tax administration of enterprise reorganizations

Guidance issued by China's State Administration of Taxation (SAT) on 24 June 2015 (Bulletin 48) is designed to promote mergers and acquisitions and reorganizations between enterprises, and to clarify issues arising from current

practices. Bulletin 48 makes major changes to guidance issued in 2010 (Bulletin 4); although Bulletin 4 remains in effect, a number of its procedural guidelines are repealed or amended. Bulletin 48 applies to enterprise reorganizations completed in 2015 and subsequent years, as well as to reorganizations for which the agreements have been signed, but the transactions have not yet been completed.
