

Extension of deadline for the manufacturers, domestic and handcrafted producers and alcoholic beverages importers adapt the labels and packaging to the tagging of Marking of Retail prices (PVP)



The Administrative Decree N° 2016/0001, issued by the National Tax and Customs Administration Office (SENIAT, for its acronym in Spanish) (“Decree N° 0001”) was published in Official Gazette N° 40.834 on January 22, 2016.

The most relevant aspects of the Decree N° 0001 are as follows:

1. Effective date from **January 7, 2016**.
2. The Decree was extended from **January 7, 2016 to April 7, 2016** so the manufacturers, domestic and handcrafted national producers and alcoholic beverages importers: (i) adjust the labels and packaging to what is established in the SENIAT Decree N° 2015/00017 that sets forth the formalities for the PVP on the labels or packaging impression, and (ii) inform to the alcoholic beverage stores the prices throughout lists previously notified to the Tax Administration.
3. The price lists of the alcoholic beverages must include this information:
 - a) Alcoholic beverage type.
 - b) Indication of the PVP and the national taxes amount.
 - c) Final price of the alcoholic beverage that the consumer must pay.
4. The alcoholic beverages stores must publish the products list in a visible place of the store.
