決議第 954/2020 / UBTVQH14 に基づく扶養控除の適用に関するガイダンス | Guidance on the application of family circumstance deduction pursuant to Resolution No. 954/2020/UBTVQH14

お世話になっております。

2020 年 6 月 23 日、税務総局は、2020 年 6 月 2 日に国会常務委員会によって発効された決議第 954/2020 / UBTVQH14 (「決議 954」) に従い、個人所得税 (「PIT」) 計算のための新しい扶養控除の適用に関するガイダンスを提供する、公式文書 No. 2546 / TCT-DNNCN (「OL 2546」) を発行しました。詳細は下記の通りです。

- 1. 新しい扶養控除は次のように適用されます:
 - 月次申告の場合、2020年7月分の個人所得税申告から適用されます。 (期限: 2020年8月20日)
 - 四半期申告の場合、2020年第3四半期分の個人所得税申告から適用されます。(期限:2020年10月30日)
- 2. 2020 年度の納税期間のうち、上記以前の 月次申告/四半期申告については、2020 年度の年次確定申告時に新しい扶養控除 を適用して、個人所得税負債を修正する ことになります。
