#### VAT in Bahrain effective 1 January 2019

Bahrain has now issued its VAT Draft Law in Arabic and approved the introduction of VAT effective from 1 January 2019 at the expected standard rate of 5%.

Introduction of VAT will be a big challenge for the local market. Businesses from a largely non-tax environment will be required to meet significant obligations critical to the operation of the new VAT system. 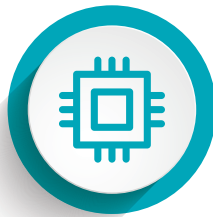
